The Board of Directors values, knowledge, backgrounds and perspectives maintain the operational ethics for the Southwest Federal Credit Union membership.

If you are **nominated** by the Nominating Committee you are not subject to the Petition Process.

Any Primary adult member, in good standing is eligible to run for a three-year term as a Board of Director Volunteer.

Board of Directors Petition Process:

Nominations may also be made by petition, signed by one percent (1%) of the membership. (A minimum of 50, maximum of 500 signatures.) All petitions should include a brief statement of qualifications, and biographical history with the application and signatures.

As a volunteer representative of Southwest Federal Credit Union, you review the financial condition of the credit union on a monthly basis. Make decisions involving the direction, vision and future by insuring that the credit union policies and procedures are followed. Generally, Volunteers Members will need to dedicate their time and talents monthly in conducting credit union business.
